

Data subjects: software users

Policy on the processing of personal data pursuant to articles 13-14 of Regulation (EU) 2016/679

Evco SpA, in its capacity as Controller of your personal data and in accordance with Regulation (EU) 2016/679, hereinafter referred to as the 'GDPR', would like to inform you that the aforesaid regulation concerns the protection of data subjects with regard to the processing of their personal data. This processing shall be based on the principles of fairness, lawfulness, transparency and the protection of your confidentiality and rights.

Your personal data will be processed in accordance with the provisions of the aforesaid regulation and the obligations of confidentiality contained therein.

Purposes and legal basis of the processing: your data will be processed in particular for the following purposes, related to compliance with legal obligations:

- to manage the cookies the website needs to function properly (technical cookies are essential to ensure the correct operation of the website and are used for the sole purpose of managing different services connected to the site itself, such as logging in).

Your data will also be used for the following purposes related to the performance of contractual and pre-contractual obligations:

- after-sales assistance;
- electronically sent information.

Processing methods. Your personal data may be processed in the following ways:

- with electronic calculator using directly managed or programmed software systems;
- data collection using IT or telematic means.

All processing takes place in accordance with the provisions of articles 6 and 32 of the GDPR, implementing the appropriate safety measures set out in the regulation.

Your data will be processed exclusively by personnel expressly authorised by the Controller and, in particular, by the following categories of authorised personnel:

- website administrators;
- programmers and analysts.

Dissemination: your data will not be communicated to third parties.

Disclosure: your personal data will not be disclosed in any way.

Your personal data may also be transferred, exclusively for the aforementioned purposes, to the following countries:

- EU nations.

Retention period. In accordance with the principles of lawfulness, purpose limitation and data minimisation and pursuant to art. 5 of the GDPR, your personal data will be retained for:

- up to 10 years from the end of the business relationship.

Cookie management: should you have any doubts or concerns regarding the use of cookies, you can intervene at any time to block their settings and processing, for example by changing the privacy settings of your browser to block specific types of cookies.

You have the right to obtain from the controller the erasure (right to be forgotten), restriction, updating, rectification and portability of the personal data concerning you, as well as the right to object to their processing, and you may exercise all the rights under articles 15, 16, 17, 18, 19, 20, 21, 22 of the GDPR.

Regulation (EU) 2016/679: Articles 15, 16, 17, 18, 19, 20, 21, 22 - Rights of the data subject

1. The data subject has the right to obtain confirmation as to whether or not personal data concerning him or her exist, even if the data have not yet been recorded, to have this communicated in an intelligible form and to have the possibility of lodging a complaint with the supervisory authority.
2. The data subject has the right to obtain details of:
 - a. the origin of the personal data;
 - b. the purposes and methods of the processing;
 - c. the logic involved when processing data with the aid of electronic instruments;
 - d. the identification details of the data controller, the processors and the representative appointed pursuant to article 5, paragraph 2;
 - e. the recipients or categories of recipient to whom the personal data may be disclosed or who may learn about them in their capacity as the national appointed representative, data processors or their representatives.
3. The data subject has the right to request:
 - a. that data be updated or rectified or that incomplete data be completed;
 - b. that data be erased, transformed into anonymous form or that unlawfully processed data be blocked, including data which are no longer necessary in relation to the purposes for which they were collected or later processed;

- c. certification to the effect that all recipients to whom the data have been communicated or disclosed have been notified of the actions referred to in letters a) and b), including their content, unless this proves impossible or involves a manifestly disproportionate effort compared to the right that is to be protected;
- d. data portability.

4. The data subject has the right to oppose, in whole or in part:

- a. on legitimate grounds to the processing of the personal data concerning him or her, even if pertinent to the purpose of collection;
- b. to the processing of the personal data concerning him or her used to send advertising material, for direct marketing purposes or to perform market research or send sales communications.
